Florida Bar Foundation rebrands, changes name to FFLA



FUNDING FLORIDA LEGAL AID

The Florida Bar Foundation is now known as FFLA. The nonprofit organization, which is the designated administrator of Florida's Interest on Trust Accounts (IOTA) program, has changed its name and rebranded to increase awareness of its purpose and raise its profile among the general public.

"Since 1956, the Foundation has been known by lawyers and those in the legal system as the trusted steward of IOTA collections and as a funder committed to increasing access to the civil justice system," Murray Silverstein, FFLA president, said. "Now, we begin our work to educate those outside of the legal community about our mission, the critical need for legal aid funding, and the valuable economic impact of accessible, free legal counsel."

FFLA funds a network of more than 35 legal aid organizations that help people of limited means. When issues like eviction, domestic violence protection, identity theft, and healthcare benefits are resolved, lives are stabilized.

Each year, approximately two million people benefit either directly or indirectly because FFLA grants enable qualified legal aid programs to employ lawyers and staff that provide free civil legal services to people who cannot afford to hire a lawyer.

"Though our name has changed, our mission, staff, board members and operations remain the same," Silverstein said. "Funding Florida Legal Aid succinctly describes what we do, making it easier for everyone to understand the role we play."





FFLA President Murray B. Silverstein's term began July 1. A partner in the newly-opened Tampa office of Stinson LLP, he practices in the areas of unfair competition, trade secrets, intellectual property and health care litigation. He earned both his bachelor's and law degrees from Stetson University. Silverstein served for eight years on The Florida Bar Board of Governors and chaired The Florida Bar Rules of General Practice and Judicial Administration Committee. He also led committees of the Florida Courts Technology Commission. He was honored with The Florida Bar President's Award of Merit in 2010 and The Florida Bar President's Pro Bono Service Award in 2011. In 2006, he received the William Reece Smith Jr. Public Service Award.

FFLA is off and rolling! In December, we distributed more than \$33 million in IOTA funds to 35 legal aid providers. Undoubtedly, this funding gives more low-income Floridians a greater chance to address and resolve their legal needs.

Right now, FFLA staff are finalizing an IOTA Distribution final report template. The 34 qualified grantee organizations that received this funding for the 2023 calendar year are required to report on the use of those funds and certify their compliance with the IOTA rule. Our report template is designed to gauge the actual work and results achieved using these funds. Once received, FFLA staff will review and summarize the information and data provided, including the detailed metrics and performance outcomes required by Florida's Supreme Court. This will also allow us to better assess the impact of the amended rule.

Recently, FFLA added Westlaw Precision with Al-Assisted Research to our statewide subscription that provides legal research tools to grantees at a fraction of the regular cost. Better technology tools provide clients with better value and service, and we are proud to make this available to our legal aid partners. Read more about this on page three.

FFLA distributes \$33.8 million in IOTA funds

On Dec. 8, 2023, the board of directors of FFLA approved the distribution of \$33,870,910 of Interest on Trust Accounts (IOTA) funds to 35 Florida legal aid organizations.

"FFLA is pleased to announce that our grantees will benefit greatly from IOTA funding that has grown to four times more than last year's funding under the 2023 amended IOTA rule," Murray Silverstein, FFLA president, said.

"These IOTA grants will enable qualified legal aid providers to serve more clients, pay their legal aid staff salaries commensurate with their experience and increase the availability of pro bono lawyers."


FFLA collected \$45,547,391 in IOTA cash collections during fiscal year 2022-23, its second year after the 2021 Bar rule amendment. \$23,343,795 in accrued interest was added to the collections.

Under Bar Rule 5.1-1(g), FFLA distributes no less than 85% of IOTA funds collected in its fiscal year no later than six months after the end of its fiscal year. FFLA's fiscal year runs July 1 to June 30.

In October, \$3,687,158 of IOTA funds were distributed to 20 qualified grantee organizations for pro bono support and enhancement. An additional \$712,162 was used for the Loan Repayment Assistance Program, and \$800,900 was used to

partially fund Children's Legal Services grants.

With a decade-long global recession beginning in 2007 and a pandemic in 2020, the U.S. Federal Reserve instituted monetary policies that held the Federal funds rate near zero for many years. This had a devastating impact on IOTA revenue. The recently amended IOTA rule and an increased Federal funds rate have allowed FFLA to fund legal aid at levels not seen since 2007.

FFLA provides AI-Assisted Research tool to grantees

FFLA has added Westlaw Precision with Al-Assisted Research to its statewide subscription that provides legal research tools to its grantees. FFLA's subscription allows more than 20 Florida legal aid organizations to access Westlaw's many tools at a reduced rate.

Westlaw, an online legal database platform, provides case histories, form builders and research tools for lawyers. As the account holder, FFLA manages payment to Westlaw and is reimbursed by each legal aid provider. FFLA's investment in Westlaw reduces the cost of it for legal aid providers, allowing them to put more funds toward other services.

The Florida Bar Foundation was one of the first statewide IOTA programs in the nation to facilitate this type of agreement more than 20 years ago. FFLA believes legal aid clients benefit from having lawyers who have access to cutting edge research tools.

According to Thompson Reuters, which owns Westlaw, their Al-Assisted Research tool uses reliable information from its

library of materials, which reduces the risk of Al-generated hallucinations, or faulty information.

FFLA is committed to exploring projects that promote complementary, not competing, technology tools that can coordinate efforts, avoid redundancy, reduce costs and share best practices.



December board of directors report

The FFLA board of directors met in Winter Park, Fla., on Dec. 8, 2023, at the Winter Park campus of Valencia College. Prior to the meeting, presentations were made by Silvia McLain, executive director of Seminole County Bar Association Legal Aid Society, and Robert L. Johnson Jr., executive director of Brevard County Legal Aid. Both presentations focused on the history and work of their respective organizations and the populations they each serve. The board is grateful for Ms. McLain's and Mr. Johnson's presentations and the work they do.

Report of the Grants Committee

The board approved \$33,870,910 for FY 2023-24 IOTA Funds Distribution grants to 35 qualified grantee organizations (see page 5). These grants are in addition to previous IOTA distributions for calendar year 2023 Loan Repayment Assistance Program (LRAP) loans (\$712,162), Children's Legal Services grants (\$800,900) and Pro Bono Support and Enhancement grants (\$3,687,158).

Total IOTA distributions equaled \$39,071,130, which is 85.7% of the \$45,547,391 in total IOTA collections received by FFLA in FY 22-23.

Additionally, the Grants Committee recommended, and the board approved, St. Michael's Legal Center for Women and Children as a qualified grantee organization eligible to receive IOTA funding.

For FY 23-24 LRAP payments, the Grants Committee recommended and the board approved funding 154 loan applications totaling \$760,393. The average amount of law school student loan debt for the applicants is \$152,208. As such, an LRAP ad hoc committee was created by President Silverstein to study and consider whether an increase in the principal loan amount for annual LRAP loans is in order. Retired Justice Peggy A. Quince was appointed as chair.

Work on a proposed IOTA Collections Spending and Reserve Policy continues

IOTA Collections Spending and Reserve Policy Task Force Chair Jim Schwarz reported that work continues on the preparation of a proposed policy. The policy is intended to provide greater economic stability to FFLA's qualified grantee organizations and instill a more consistent and predictable IOTA distribution process. It will also modulate spending and provide greater transparency and more notice of expected IOTA distributions from FFLA allowing grantees more time for planning, building infrastructure and budgeting. Mr. Schwarz reported that the task force anticipates that it will have a proposed policy ready for review at the Executive Committee's Jan. 31 meeting.

Presentation and Review of Audited Financial Statements set for January 31, 2024

Audit Committee Chair Steve Salzer reported that FFLA's and The Florida Bar Foundation Endowment's Audited Financial Statements are expected to be completed by Jan. 31. Heather Mosier, a partner with Carr Riggs & Ingram CPAs, was present to answer questions and comment on the proposed schedule for completion.

Executive Director Report

Donny MacKenzie provided a short report on FFLA's updated schedule of insurance coverage and its housewarming event. He reported that approximately 75 people toured FFLA's new offices, new FFLA signage was unveiled, a Legacy Garden was dedicated and a tree was ceremonially planted in honor of the late Alan B. Bookman, former Florida Bar president and beloved husband of Connie Bookman, former president of The Florida Bar Foundation.

In addition, the housewarming included the playing of a Public Service Announcement prepared by Gary Yordon of Zachary Productions for FFLA. The PSA was replayed at the board meeting and can be found on FFLA's YouTube channel (@FundingFLA). Mr. MacKenzie then yielded the floor to Jessica Brown, FFLA's Communications Director, who gave an overview of FFLA's name and brand standards.

Next Meeting

The Board's next scheduled meeting will be on March 21, 2024, in Tampa, Fla. Former Medal of Honor Winner Hon. E.J. Salcines Jr. is hosting and coordinating the event, for which FFLA is most grateful.
