2018 MEDAL OF HONOR AWARD FOR A LAWYER
HOWARD TALENFELD
TALENFELD LAW



As managing partner of Talenfeld Law and founding president of Florida's Children First, Howard Talenfeld's legislative efforts have significantly improved services for dependent children with special needs and foster children. His advocacy led to an improved child welfare system, and he has spent almost 40 years representing at-risk children and adults. After Talenfeld was the lead counsel in a Broward County foster care class action in 1998, the district nearly tripled its child welfare budget with the settlement that was reached. For almost 20 years after the settlement, Talenfeld continued to work with state and local agencies to implement the terms and improve the delivery of services to dependent children. Talenfeld helped pass several pieces of legislation to protect dependent and foster children, most significantly a recent statute that provides legal representation to dependent children with special needs. In 2002, Talenfeld established Florida's Children First, uniting advocates for children across the state. In 2011, he developed the Tracey McPharlin Dependency Pro Bono Project to recruit and train attorneys to provide pro bono representation of at-risk dependent children. He was a member of The Florida Bar Legal Needs of Children Committee for more than 10 years, serving as its chair in 2009-2010. He is also a 2006 recipient of the President's Pro Bono Service Award for the 17th Judicial Circuit.

2018 MEDAL OF HONOR AWARD FOR A NON-LAWYER
DR. LOUIS B. ST. PETERY
TALLAHASSEE PRIMARY CARE ASSOCIATES



A pediatric cardiologist, Dr. Louis B. St. Petery has been a phenomenally effective advocate for reform of Florida's Medicaid system, which has led to successful litigation and an immense impact on the care provided to poor children. Committed to improving medical care for children, he sued on behalf of those on Medicaid who weren't receiving the medical or dental care to which they were entitled. In the end, a settlement was reached that resulted in millions of additional dollars in funding and a multi-year process that would transform the program from one of the worst in the nation to one performing at national norms. When he recruited counsel to block the Department of Health from using a new screening tool that knocked 13,000 children with special health care needs out of Florida's Children's Medical Services, he served as the plaintiff's pro bono expert witness, and the state was forced to cease using the screening tool. For more than 25 years, St. Petery served as executive director of the Tallahassee Pediatric Foundation, a nonprofit organization formed by the Florida Legislature in 1984 to coordinate the activities of the pediatricians in Tallahassee treating children on Medicaid and the State Child Health Insurance Program (SCHIP). He was appointed by Gov. Jeb Bush to the Florida Healthy Kids Board, a nonprofit corporation created by the Florida Legislature to oversee SCHIP. St. Petery also has served on the CMS Network Advisory Council and on the Legislative Council of the Florida Medical Association.

JANE ELIZABETH CURRAN
DISTINGUISHED SERVICE AWARD
SHARON BOURASSA
LEGAL AID SERVICE OF BROWARD COUNTY



Sharon Bourassa has worked at Legal Aid Service of Broward County since 1981. As the Director of Special Projects, she pursues and prosecutes cases that impact the low-income community. Bourassa has represented families in cases involving federal and state environmental laws, housing laws and local code enforcement laws. She became involved in representing extremely low-income clients and families in housing matters in 1986. Since then, she has focused her practice on major impact cases that result in significant impact or class-wide relief to local, state, and nationwide segments of the low-income population. She has litigated cases against the U.S. Department of Housing and Urban Development for operating federal housing projects that are in violation of applicable housing laws, the U.S. Environmental Protection Agency for its failure to enforce laws concerning a Superfund waste site, and other governmental entities for failure to either comply with applicable code enforcement, housing, and relocation laws or for improper enforcement of laws. Most recently, Sharon has been instrumental in developing programs to represent welfare and low-income women and men whose legal issues are keeping them from continuing their education or job training. This includes representing them in child custody, domestic violence, evictions, foreclosure and other consumer matters. The program's holistic approach ensures these persons receive an appropriate assessment and placement into higher education or work activities that lead to a better future for them and their families. Sharon and her team also represent clients who have been unfairly sanctioned by federal and state programs.

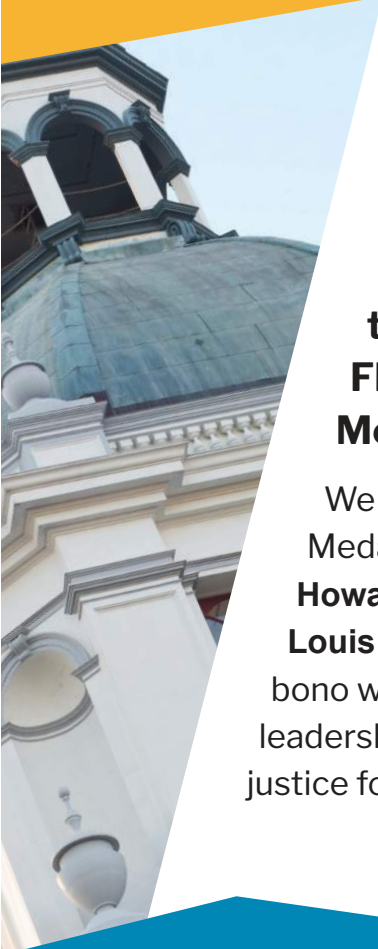

JANE ELIZABETH CURRAN
DISTINGUISHED SERVICE AWARD
MARCIA CYPEN
LEGAL SERVICES OF GREATER MIAMI



Marcia Cypen joined Legal Services of Greater Miami in 1974 as a law clerk and was hired as a staff attorney two years later. After managing the Health and Income Maintenance Unit and being promoted to deputy director, she began serving as executive director in 1983. For more than three decades, Cypen led the largest provider of broad-based civil legal services for the poor in Miami-Dade and Monroe Counties. She oversaw a 60-member staff, including more than 25 attorneys, who serve 20,000 people a year and successfully resolve the daily legal problems of low-income, vulnerable residents. She successfully challenged issues from Medicaid cutbacks to durational residency requirements limiting home care benefits for elderly. Her vision resulted in one of the first Community Economic Development departments in a legal services program. Cypen also worked to develop innovative programs for veterans returning from service, disabled children seeking to avoid institutionalization, people with AIDS, homeless people, ex-prisoners struggling to reintegrate into the community, and low wage workers. Under her leadership, Legal Services of Greater Miami established online intake available in multiple languages, a Disaster Legal Assistance Unit in the aftermath of Hurricane Andrew, and most recently a foundation. In her current role as executive director emeritus, Cypen continues to provide leadership by supporting the new executive director and developing the resources for the organization to continue its mission of achieving justice through high-quality legal representation.

STEVEN M. GOLDSTEIN AWARD FOR EXCELLENCE

The Steven M. Goldstein Award for Excellence is a biennial award recognizing high quality, significant impact work by a Florida Bar Foundation grantee organization. The award honors the memory of Goldstein, a former legal services attorney and professor of law at Florida State University College of Law, who passed away in 1994 at the age of 49. He was a tireless advocate of the legal rights of the poor and disadvantaged and was respected nationally for his dedication to upholding the constitutional rights of those with unpopular causes.

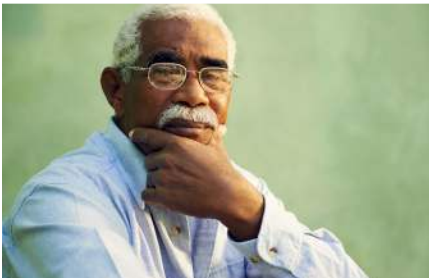
