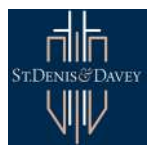

DAVID B. ROTHMAN, ESQ.
ROTHMAN & ASSOCIATES, P.A.



David B. Rothman, founder of criminal defense firm Rothman & Associates, P.A., in Miami, is being honored for his dedication, commitment, and tireless volunteer work on behalf of numerous Bar and legal organizations, and his steadfast integrity while representing those facing criminal charges, as well as lawyers facing disciplinary action. Rothman, who earned his law degree from the University of Florida, served as assistant state attorney in Miami-Dade County prior to entering private practice. Since 1995, he has been an adjunct professor at the University of Miami School of Law. He served as chair of Innocence Project of Florida in 2013-14 and of The Florida Bar Criminal Law Section in 2014-15. Rothman has supported many causes that benefit the courts and the Bar by lobbying and building relationships behind the scenes. His efforts are impactful if not in the limelight. Most recently, on behalf of the Criminal Law Section, he worked alongside the Board of Governors Disciplinary Procedures Committee to form a rule requested by the Court relating to emergency suspension for lawyers charged with a felony. Rothman served on the Foundation's board from 2011-17 and previously served on The Florida Bar Board of Governors from 1999-2011, where he chaired its Disciplinary Review Committee for more than 10 years. He is a past president of the Miami-Dade County Bar Association and the Florida Association of Criminal Defense Lawyers, which awarded him the Steven Goldstein Award, their highest honor, in 2019. In 2014, he was awarded the Miami-Dade County Bar's David W. Dyer Professionalism Award.

KIMBERLY L. RODGERS, ESQ.
COMMUNITY LAW PROGRAM



Kimberly L. Rodgers has led Community Law Program in Pinellas County since 2004. She is being honored for serving and leading Community Law Program for almost two decades, where her unwavering belief in fairness and equity, her inspiring work ethic, and her zeal for protecting client rights have led to lasting change in her community. After earning her law degree from Stetson University College of Law in 1998, Rodgers worked as a law clerk for the city of St. Petersburg and the U.S. District Court, Middle District of Florida. She opened her own family law firm in 2000 before becoming the executive director of Community Law Program (CLP). CLP serves more than 3,500 clients each year through programs that help families with children avoid eviction, survivors of domestic violence obtain injunctions and foster children who have outgrown the system. Their lawyers also provide bankruptcy, family law, probate and housing rights advice clinics, and assist Pinellas residents with voting rights restoration, driver license issues and records expungement. Rodgers supports her community volunteering on the boards of the Homeless Leadership Alliance of Pinellas as secretary, the School Advisory Committee of Thurgood Marshall Fundamental Middle School, CASA Pinellas, and Lighthouse of Pinellas. In 2017, Rodgers was recognized with the Kay B. Myers Pro Bono Coordinator Award by the Florida Pro Bono Coordinators Association. She has previously been named the INSPIRE! Iconic Woman of the Year by the St. Petersburg Chamber of Commerce and received the Christina Ippolito Award for Outstanding Contribution in Family Law.

PRESIDENT'S AWARD FOR EXCELLENCE

MARIA C. GONZALEZ, ESQ.



Maria C. Gonzalez, Esq., is a board certified marital and family law lawyer in Miramar. She has served on The Florida Bar Foundation's board of directors since 2018. Currently, she serves as chair of the Foundation's Grants Committee. Maria was recognized with the Honorable Raymond T. McNeal Professionalism Award in 2018 and the Honorable Hugh E. Stearns Community Service Award in 2016. She is past chair of the Family Law Section of The Florida Bar, past chair of the Marital and Family Law Board Certification Committee and past president of The First Family Law American Inn of Court. Previously, she was appointed to the Florida Supreme Court's Commission on Professionalism and Civility. In 2018, she was appointed to serve on the committee tasked with updating the Bounds of Advocacy which sets goals and guidelines for family lawyers in Florida. For her willingness to volunteer whenever asked and without hesitation, her steadfast commitment to facilitating fiscal support for the Foundation, and her calm, rational and assertive leadership, Gonzalez is the recipient of the 2023 President's Award for Excellence.

PAUL DOYLE CHILDREN'S ADVOCACY AWARD

The Paul Doyle Children's Advocacy Award honors Paul C. Doyle, founding director of the Foundation's Legal Assistance for the Poor and Law Student Assistance grant programs (1991 - 2013) in recognition of his commitment to high-quality legal representation of Florida's low-income children. The award recognizes and encourages systemic legal advocacy on behalf of low-income children by nonprofit Florida organizations.

Winner



The Foster Youth Disability Advocacy Project ensures that foster youth with developmental disabilities receive the government benefits to which they are entitled. Medicaid Home and Community Based Services benefits require a detailed application process and, in event of denial, a complicated appellate process before the benefits can be awarded.

First Runner-up



The Medicaid Aging Out Project successfully challenged an unadopted rule that illegally narrowed the pool of medically fragile children eligible for automatic enrollment into a Medicaid Waiver program. Without automatic enrollment, these children were forced onto a waitlist of 55,000 people. The rule language was amended and corrective action was undertaken to implement the change.

Second Runner-up



AIJ's Lucha Program protects survivors of violence and their children by helping them achieve full residency, reunification with family members, and the opportunity to integrate and contribute to the community in which they live. It prevents family separation by ensuring that the children of survivors of violence are able to stay with their parent and get immigration relief that allows them to stay together in the United States.

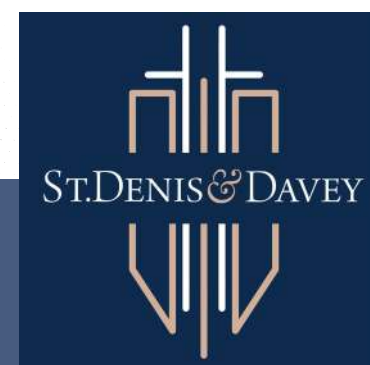
