Formerly a judge on Florida's First District Court of Appeal, Jacksonville appellate lawyer William A. Van Nortwick Jr. is partner-in-charge of Akerman LLP's national pro bono program and a member of the Florida Commission on Access to Civil Justice. He is being honored for his decades of work contributing to the infrastructure for pro bono and legal services organizations in Florida. He is a past president of The Florida Bar Foundation and former director and two-term president of Foundation grantees Jacksonville Area Legal Aid and Florida Legal Services. He is immediate past chair of The Florida Bar's Standing Committee on Pro Bono Legal Service, having served since 1997, and previously chaired The Florida Bar/Florida Bar Foundation Joint Commission on the Delivery of Legal Services to the Indigent, which helped establish pro bono reporting requirements. He chaired The Florida Bar's symposium on equal access to justice, whose recommendations led to the first state funding for civil legal aid, and was instrumental in developing the statewide One Campaign promoting pro bono work. He began doing pro bono work during his first year in private practice at the Jacksonville law firm of Milam, Martin and Ade, which he joined in 1970 right out of law school at the University of Florida. In an early case he helped represent three African-American students who were expelled from school following a racially charged incident on a school bus. The students were eventually reinstated. He later donated more than 200 pro bono hours helping establish a medical clinic in an underserved Jacksonville neighborhood. He has been recognized by the American Bar Association and the Florida Supreme Court for his pro bono work and distinguished service.

The Florida Bar Foundation has established the Jane Elizabeth Curran Distinguished Service Award to honor Curran for her 33 years as the organization's founding executive director. Curran is the first recipient of the award in recognition of her contributions to the Foundation, to the national Interest on Lawyers' Trust Accounts (IOLTA) movement, and to access to justice statewide and nationally. She was recruited to The Florida Bar Foundation in 1982 to lead the organization as it launched the nation's first Interest on Trust Accounts program, which was authorized by the Florida Supreme Court in 1981. She led the efforts to make the state's IOTA Program mandatory, to achieve interest rate comparability so that IOTA accounts earn the same interest rates available to similar bank customers, and to create innovative grant programs to improve legal services delivery. Curran was not only the Foundation's executive director, but also the director of its Improvements in the Administration of Justice Grant Program, which has helped launch or fund a number of important projects, including the Innocence Project of Florida.

PRESIDENT'S AWARD FOR EXCELLENCE JULIO C. JARAMILLO



Julio C. Jaramillo was president-elect of The Florida Bar Foundation when lymphoma forced him to defer his service in the fall of 2014. He had also been vice chair of The Florida Bar's Vision 2016 Access to Legal Services Committee, and by virtue of his Foundation office was slated to serve on the Florida Commission on Access to Civil Justice. When Jaramillo passed away Jan. 19 at the age of 48, The Florida Bar Foundation lost a great leader, and a beautiful family lost an adoring husband and father. In the words of Senior Judge Emerson R. Thompson Jr., who as Foundation president chose Jaramillo to receive, posthumously, the President's Award for Excellence, "He is a charismatic leader that everyone was eager to follow." Jaramillo practiced law in the area of civil litigation. He earned a bachelor's degree in international relations from Florida International University and his law degree from the University of Florida College of Law. He had served The Florida Bar as a member of its Grievance Mediation & Fee Arbitration Committee, as well as one of its local grievance committees. He is a past member of the Cuban-American Bar Association, the American Bar Association and the Florida Justice Association. A founder of the Colombian American Bar Association, he served as president of the Colombian American Service Association and worked pro bono for the Dade County Bar Association's "Put Something Back" program. He is a Florida Bar Foundation Fellow and began serving on the board in 2005. He was a member of several Foundation committees and chaired the investment and development committees. He is survived by his wife, Patricia, his sons Julian, 4, and Joaquin, 2, his brother, Dr. David Jaramillo, and sisters Patricia Rubio and Elaine Mangia. KEYNOTE SPEAKERS



JOSÉ MANUEL GODÍNEZ -SAMPERIO

A staff attorney at Florida Bar Foundation grantee Gulfcoast Legal Services, José Manuel Godínez-Samperio focuses his practice on landlord-tenant issues. His effort to secure the right to practice law in Florida made national headlines when his eligibility for membership in The Florida Bar was called into question because of his undocumented status. It took more than three years and the passage of a bill in the Florida Legislature for this high school valedictorian, Eagle Scout and Florida State University College of Law graduate, who was brought to the United States from Mexico by his parents at the age of 9, to gain entry to the legal profession.



LEONARDO LEAL

Leonardo Leal graduated June 14 from Stanford University, where he was on a full scholarship, and has accepted a position at Shell Oil in Houston. Braden River High School's 2011 valedictorian, Leal is a former client of the Florida Bar Foundation-funded GLS CHILD project at Gulfcoast Legal Services, where staff attorney Adriana Dinis helped him obtain Special Immigrant Juvenile Status. Without it, he would not have been able to become a legal permanent resident of the United States and might not have had the wherewithal to pursue his college dreams.
