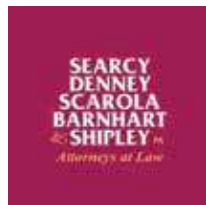

2017 MEDAL OF HONOR AWARD FOR A NON-LAWYER

JANE ELIZABETH CURRAN
FOUNDING EXECUTIVE DIRECTOR
THE FLORIDA BAR FOUNDATION



A pioneer among Bar Foundation leaders nationally, Jane Elizabeth Curran was recruited to The Florida Bar Foundation in 1982 to lead the organization as it launched the nation's first Interest on Trust Accounts (IOTA) program, which was authorized by the Florida Supreme Court in 1981. She served as the Foundation's executive director for nearly 33 years until her retirement in 2014 and helped expand IOTA, known as IOLTA in many states, as a funding mechanism for civil legal aid throughout the country. She shared ideas and best practices, provided training and technical assistance, and mentored her peers in other states. Curran led the Foundation as it worked to make Florida's IOTA program mandatory, to achieve interest rate comparability so that IOTA accounts earn the same interest rates available to similar bank customers, and to create innovative grant programs to improve the justice system and the delivery of civil legal services. She served as president of the National Conference of Bar Foundations and the National Association of IOLTA Programs and a member of the American Bar Association's IOLTA Commission. She was not only the Foundation's executive director, but also the director of its Improvements in the Administration of Justice grant program, which has helped launch or fund a number of important projects, including the Innocence Project of Florida.

2017 MEDAL OF HONOR AWARD FOR A LAWYER

JOHN F. HARKNESS, JR.
EXECUTIVE DIRECTOR
THE FLORIDA BAR



John F. “Jack” Harkness Jr., a nationally recognized legal visionary and the nation’s longest-serving bar executive, has served as executive director of The Florida Bar since 1980. When Harkness assumed leadership of The Florida Bar, it had 27,713 members, a staff of 122 and an annual budget of \$7.1 million. He now oversees a staff of 360 – with 284 working at the Tallahassee headquarters complex recently named in his honor – and a budget of \$44.2 million for an organization with more than 105,000 members. In his 37 years of leadership, he’s advised every Bar president and had an active role in all of the Bar’s major initiatives, including efforts to educate Bar members and the public about access to justice, judicial merit retention, court funding and the work of The Florida Bar Foundation and its grantees. He is recognized for establishing the Bar’s ethics hotline, Attorney Consumer Assistance Program and countless other professionalism committees and programs of The Florida Bar, and he has been a strong advocate of pro bono service, legal services funding and a fair and impartial judiciary. Harkness announced earlier this year his intention to retire at the end of 2017. Prior to joining The Florida Bar, Harkness served for six years as the State Courts Administrator.

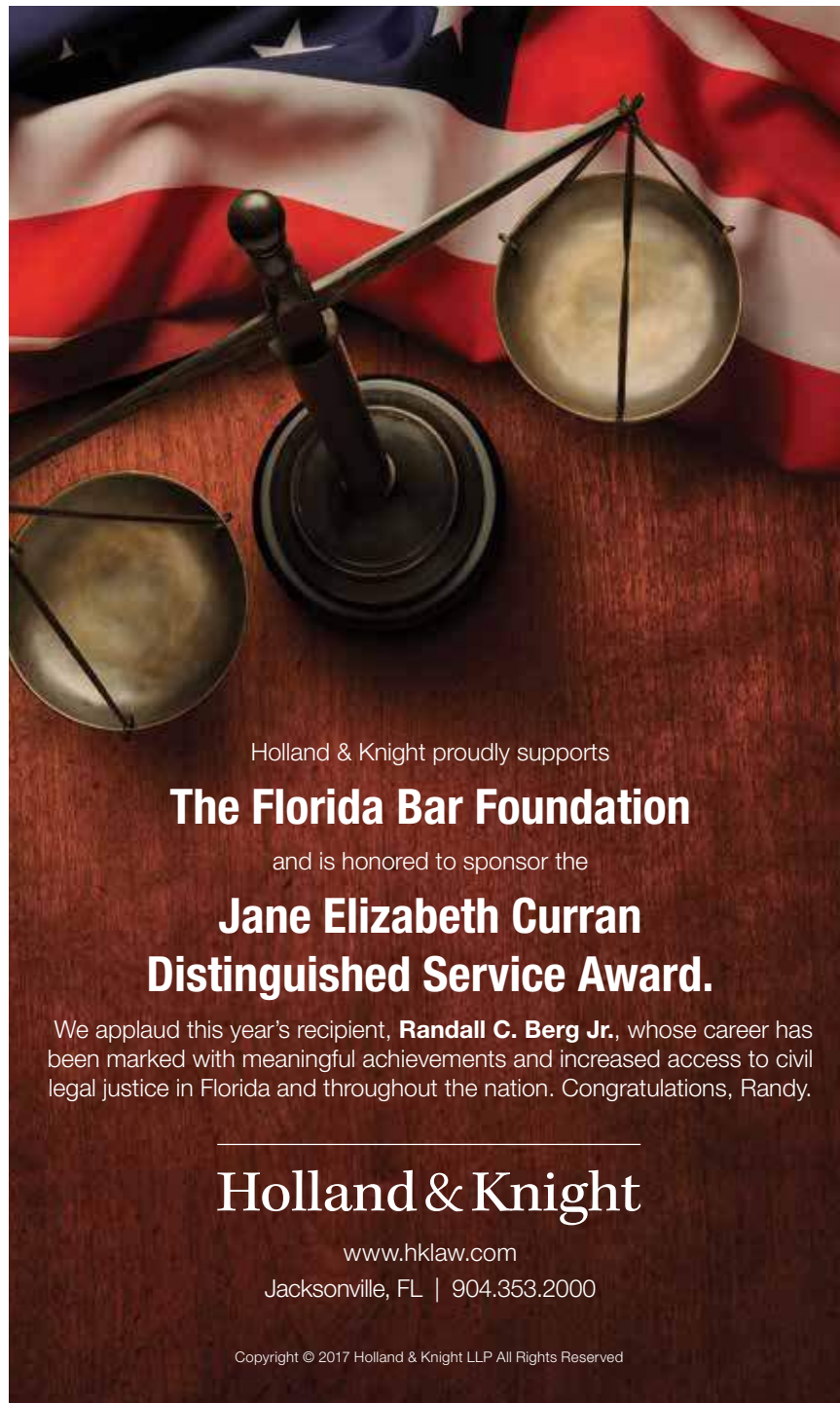

RANDALL C. BERG, JR.
FLORIDA JUSTICE INSTITUTE



Randall C. Berg Jr. founded and has served since 1978 as executive director of the Florida Justice Institute (FJI), a public interest law firm that conducts civil rights litigation and advocacy in the areas of prisoners' rights, housing and disability discrimination, and other areas that impact Florida's poor. Based in Miami, FJI handles major, systemic civil rights litigation statewide. Berg previously established and directed the Volunteer Lawyers' Project for the U.S. District Court for the Southern District of Florida, as well as what is now known as the "Put Something Back" program of the Dade County Bar Association. He went on to serve as a consultant to the American Bar Association and the Legal Services Corporation for establishing pro bono programs nationwide. Berg worked to develop the nation's first Interest on Trust Account (IOTA) program in Florida and assisted other states in establishing their programs. He also defended the constitutionality of the funding mechanism, known elsewhere as IOLTA, as executive director and founder of the National IOLTA Clearinghouse and later as legal counsel for the National Association of IOLTA Programs. IOLTA has generated more than \$4 billion nationwide, primarily to fund legal services for the poor. Berg is past president of the American Civil Liberties Union of Florida and is an adjunct clinical professor at the University of Miami School of Law.

Judge Edwin A. Scales III of the Third District Court of Appeal was appointed by the Florida Supreme Court to the board of The Florida Bar Foundation in 2015. Prior to his judicial appointment in 2013 he was a sole practitioner in Key West concentrating in appellate litigation, commercial and real estate litigation, administrative law and mediation. He was re-elected four times to The Florida Bar Board of Governors, serving three years on the executive committee and chairing its legislation committee and its Citizens Forum. He also served as vice chairman of the Florida Commission on Ethics, and from 2000 to 2005 on the Federal Judicial Nominating Commission for Florida's Southern District. Shortly thereafter he was appointed twice to the Judicial Nominating Commission for Florida's 16th Judicial Circuit. He served a four-year term on the City Commission of Key West and chaired the Board of Trustees of Florida Keys Community College.

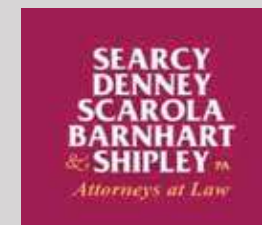
